



**Undertaking by the Applicant for submitting their application to the platform [www.anshulikadubey.com](http://www.anshulikadubey.com) to solicit project-related services from Anshulika Dubey.**

By submitting the application, the applicant agrees to the following Undertaking Statement:

1. The applicant hereby affirms that he/she/they are above 18 years of age, an Indian citizen holding an Indian passport. The applicant may be residing outside India but affirms that he/she they have an Indian citizenship.
2. The applicant hereby certifies that he/she has read and understood all the information listed on the platform ([www.anshulikadubey.com](http://www.anshulikadubey.com)) and that he/she is legally authorized to submit all the information and documents related to the project and that the information given by the applicant is true and correct. The applicant agrees that he/she/they are fully authorized to make this application and are not under any disability whether legal or contractual which prevents them from submitting this application.
3. The applicant must own the copyright of the project (script/screenplay, logline, synopsis) on an exclusive basis, and the project, including but not limited to submissions, must be entirely original.
4. The submission/s, i.e., the film synopsis, logline, story, treatment and the script (if any) must already be registered with a Screenwriters Association (or any other equivalent and valid association/authority)

The application, or any part thereof, should not violate any applicable laws. Neither should it violate/infringe any other third-party rights including any form of intellectual property.

6. The application and the submission material must be free from any charges, liens, encumbrances or any other third party rights.

The application must not contain any confidential information or any other information relating to any third party that the applicant is not authorized to use or disclose under contract or otherwise. The applicant indemnifies Anshulika Dubey and the Platform ([www.anshulikadubey.com](http://www.anshulikadubey.com)) against any claims against the aforementioned clauses.
8. The applicant understands that the Anshulika Dubey is a film producer and a creator herself and may professionally create several literary and dramatic works (Works). 9. The project documents may be asked for electronically by email or in hard copy. The applicant is aware of and understands the risks associated with electronic correspondence by email. In particular, email can be unwittingly lost or read, received, copied or falsified by outside parties, which may result in considerable damages.

The recordings shall be solely the property of Anshulika Dubey and the applicants will have no claim over the recordings. Although they will be given access to the recordings for their individual use but they agree to keep the recordings confidential and will not be permitted to share them.
12. The decision of selection of an application will be final and binding.
13. Anshulika Dubey reserves the right to change the Undertaking, Terms & Conditions and Privacy Policy of Platform without prior intimation.

The applicant confirms, undertakes and agrees that in the event the applicant's project selected by Anshulika Dubey for Script Feedback services and is subsequently produced and released as a feature film in the market through audio visual mediums such as OTT, Satellite or Theatrical, the applicant shall provide the 'Script Consultant' dredit to Anshulika in the film's closing credits.
15. The applicant acknowledges that the representations and warranties, indemnities, governing law, dispute resolution, warranty disclaimer shall survive the efflux of time.

16. Nothing herein shall be deemed to create a partnership, agency, or an employer-employee relationship between the applicant and Anshulika Dubey
17. All disputes pertaining to this application shall be finally settled by arbitration in accordance with the Indian Arbitration & Conciliation Act, 1996. The venue of the said arbitration shall be in Bengaluru and the courts in Bengaluru alone will have jurisdiction in the matter. The proceedings of arbitration shall be conducted in English language.

The applicant will have the responsibility to intimate them about the agreements and its clauses and deliverables.
